

# Terms of Service Agreement

PLEASE READ THE FOLLOWING TERMS OF SERVICE AGREEMENT CAREFULLY. BY ACCESSING OR USING OUR SITES AND OUR SERVICES, YOU HEREBY AGREE TO BE BOUND BY THE TERMS AND ALL TERMS INCORPORATED HEREIN BY REFERENCE, AS UPDATED FROM TIME TO TIME. IT IS THE RESPONSIBILITY OF YOU, THE USER, TO READ THE TERMS AND CONDITIONS BEFORE PROCEEDING TO USE OUR SITES. IF YOU DO NOT EXPRESSLY AGREE TO ALL OF THE TERMS AND CONDITIONS, THEN PLEASE DO NOT ACCESS OR USE OUR SITES OR OUR SERVICES. THIS TERMS OF SERVICE AGREEMENT IS EFFECTIVE AS OF 05/25/2018.

## ***Acceptance of terms***

The following Terms of Service Agreement (the "TOS") is a legally binding agreement that shall govern the relationship with our users and others which may interact or interface with Victory Family Church, also known as Victory, located at 21150 Route 19, Cranberry Township, Pennsylvania 16066, in association with the use of all websites owned and operated by Victory (the "Websites") and their associated Services, which shall be defined below.

Victory Family Church also respects the privacy of our users, as well as the desire of our users to keep their personal information secure. By accessing or using our Websites and our Services, you hereby give consent to the collection and use of any non-personally identifiable information as well as personally identifiable information, as discussed at length in our Privacy Policy. You can access our Privacy Policy in the footer of the site.

## ***Description of website services offered***

Our Websites are non-profit websites which have the following description:

The purposes of our Websites include (1) communicating our values, mission, culture, and community involvement, (2) communicating details related to events and opportunities at Victory, (3) providing electronic methods for contacting the church, planning in-person visits, and joining mailing lists, and (4) securely receiving online donations and registrations.

Any and all visitors to our websites shall be deemed as "users" of the herein contained Services provided for the purpose of this TOS.

The user acknowledges and agrees that the Services provided and made available through our websites are the sole property of Victory Family Church. At its discretion, Victory Family Church may offer additional website Services and/or products, or update, modify or revise any current content and Services, and this Agreement shall apply to any

and all additional Services and/or products and any and all updated, modified or revised Services unless otherwise stipulated. Victory Family Church does hereby reserve the right to cancel and cease offering any of the aforementioned Services and/or products. You, as the end user acknowledge, accept and agree that Victory Family Church shall not be held liable for any such updates, modifications, revisions, suspensions or discontinuance of any of our Services and/or products. Your continued use of the Services provided, after such posting of any updates, changes, and/or modifications shall constitute your acceptance of such updates, changes and/or modifications, and as such, frequent review of this Agreement and any and all applicable terms and policies should be made by you to ensure you are aware of all terms and policies currently in effect. Should you not agree to the updated, revised or modified terms, you must stop using the provided Services forthwith.

Furthermore, the user understands, acknowledges and agrees that the Services offered shall be provided "AS IS" and as such Victory Family Church shall not assume any responsibility or obligation for the timeliness, missed delivery, deletion and/or any failure to store user content, communication or personalization settings.

### ***Age Requirement to Use the Websites***

The Websites are offered and available to users who are thirteen (13) years of age or older. However, users between the ages of thirteen (13) and eighteen (18) must have a parent or legal guardian review, acknowledge and agree to these Terms of Use prior to such use. By using the Websites, you represent and warrant that you meet the requirements listed above and have legally entered into a binding contract with the Church and are bound by such terms. If you do not meet these requirements, you must not access or use the Website.

### ***Account security***

To access the Websites or some of the resources it offers, you may be asked to provide certain registration details or other information. All notices from the Church intended for receipt by you will be deemed delivered and effective when sent to the email address you provide on any of the Websites.

### ***Content placed or made available for company services***

Victory Family Church shall not lay claim to ownership of any content submitted by any visitor or user, nor make such content available for inclusion on our website Services. Therefore, you hereby grant and allow for Victory Family Church the below listed worldwide, royalty-free and non-exclusive licenses, as applicable:

- c) For any other content submitted or made available for inclusion on the publicly accessible areas of Victory Family Church's sites, the continuous, binding and completely sub-licensable license which is meant to permit to use, distribute, reproduce, modify, adapt, publish, translate, publicly perform and/or publicly display said content, whether in whole or in part, and the incorporation of any such Content into other works in any arrangement or medium current used or later developed.

Those areas which may be deemed "publicly accessible" areas of Victory Family Church's sites are those such areas of our network properties which are meant to be

### ***Contributions to company website***

### ***Monitoring and Enforcement***

We have the right to remove any User Contributions for any or no reason in our sole discretion. Additionally, we have the right to take any action with respect to any User Contribution that we deem necessary or appropriate in our sole discretion.

Without limiting the foregoing, we have the right to fully cooperate with any law enforcement authorities or court order requesting or directing us to disclose the identity or other information of anyone posting any materials on or through the Websites, if known. THE LAWS OF OHIO WILL GOVERN THE CONTENT AND MATERIALS CONTAINED IN THE WEBSITES, WITHOUT GIVING EFFECT TO ANY PRINCIPLES OF CONFLICTS OF LAWS AND EXCLUDING THE UNITED NATIONS CONVENTION ON THE INTERNATIONAL SALE OF GOODS. ### ***General information***

#### **ENTIRE AGREEMENT**

This TOS, together with our Privacy Policy, constitutes the entire agreement between you and Victory Family Church and shall govern the use of our Services, superseding any prior version of this TOS between you and us with respect to Victory Family Church Services. You may also be subject to additional terms and conditions that may apply when you use or purchase certain other Victory Family Church Services, affiliate Services, third-party content or third-party software. The Privacy Policy is incorporated herein by reference. You can access our Privacy Policy in the footer of the site.

#### **CHOICE OF LAW AND FORUM**

It is at the mutual agreement of both you and Victory Family Church with regard to the TOS that the relationship between the parties shall be governed by the laws of the state of Pennsylvania without regard to its conflict of law provisions and that any and all claims, causes of action and/or disputes, arising out of or relating to the TOS, or the relationship between you and Victory Family Church, shall be filed within the courts having jurisdiction within the County of Butler, Pennsylvania or the U.S. District Court located in said state. You and Victory Family Church agree to submit to the jurisdiction of the courts as previously mentioned, and agree to waive any and all objections to the exercise of jurisdiction over the parties by such courts and to venue in such courts.

#### **WAIVER AND SEVERABILITY OF TERMS**

At any time, should Victory Family Church fail to exercise or enforce any right or provision of the TOS, such failure shall not constitute a waiver of such right or provision. If any provision of this TOS is found by a court of competent jurisdiction to be invalid, the parties nevertheless agree that the court should endeavor to give effect to the parties'

intentions as reflected in the provision, and the other provisions of the TOS remain in full force and effect.

### **STATUTE OF LIMITATIONS**
